ELDERLY EXEMPTION QUALIFICATION WORKSHEET

The Town of Lyndeborough has adopted an elderly exemption that increases the basic elderly exemption offered under state law. To qualify for an elderly exemption, applicants must be at least 65 years of age prior to April 1 of the year in which you first apply for the exemption and must have been a New Hampshire resident for at least 3 consecutive years.

Criteria

Income limits are set at \$30,000 if single or \$40,000 if married. Income is described as net income and includes social security and pension income, interest, dividends and other income. The following items are **excluded:** Life insurance paid on the death of an insured individual, proceeds from the sale of an asset, and expenses incurred in the course of conducting a business.

Net assets, real and personal property, cash, certificates of deposit, IRA's, stocks, bonds, and other assets owned must be less than \$ 70,000. Net assets exclude the value of the applicant's actual residence and the land upon which it is located up to two acres or the minimum family lot as specified by local zoning.

In addition, the property for which the exemption applies must be:

- 1. owned by the applicant, or owned jointly or in common with the applicant's spouse OR
- 2. owned by the applicant's spouse if married for at least five consecutive years **OR**
- 3. owned by the applicant jointly or in common with a person who is not the applicant's spouse (if the applicant meets the age requirement) **OR**
- 4. Property must meet the definition of a residential real estate, per RSA 79:39-a (c), which includes the housing unit which is the person's principal home and related structures. It does not include attached dwelling units and unattached structures used or intended for commercial or other non-residential purposes.

Exemption Amounts

The elderly exemption adopted exempts assessment value from total value based on applicant's age:

Age 65-75 \$ 45,000 Age 75-80 \$ 65,000 Age 80 and up \$ 90,000

Application Process

To submit an application for an elderly exemption, please fill out the enclosed application and Elderly Exemption Qualification Worksheet. Also, a copy of the applicant's most recent income tax filing (or statement indicating that the applicant is exempt from filing), state interest and dividends tax form and any inventory forms filed in any other town need to be submitted. Financial information will be kept in the strictest of confidence and destroyed once verification is complete.

ELDERLY EXEMPTION QUALIFICATION WORKSHEET

Questions concerning the requirements and application process may be directed to the Selectmen's Office. RSA 72:33, VI allows Selectmen or Assessing Officials to require those receiving tax exemptions or credits to re-file their qualifying information periodically but no more frequently than annually. Failure to file such periodic statements may, at the discretion of the Assessing Officials, result in a loss of the exemption or tax credit for that year.
